Mattresses and pillows, upper material woven, knitted or non-woven; made of cotton, polyester, acrylic (i.a. Dralon®), polypropylene, polyamide and its blends; printed (i.a. digital print, rubber print), yarn, dope or piece dyed; partly with stain-resistant, waterproof and water repellent finish (BIONIC FINISH ECO®), partly with acrylate or polypropylene coating, synthetic leather made of 100 % polyester with PU-foil, colours brown; filling made of polyester or viscose fibres and/or polyurethane foam in different qualities (standard-, high resilience-, viscoelastic- and pneumatic viscoelastic foam, hyper soft foam and flame retardant polyurethane foam, max. 50 kg/m<sup>3</sup>, partially bonded); incl. accessories (edge bindings, elastic tapes, cords, labels, non-woven/waddings, zippers, hook and loop fasteners, sewing and quilting threads, metal and plastic accessories, PU-foam glues); produced by using materials certified according to STANDARD 100 by OEKO-TEX®.


The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class II** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for products with direct contact to skin.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
